The Ground Rules provide, in brief, that the suspension of Operations will be in force for one year w.e.f. 22 August, 2008. While the two groups have agreed to abjure the path of violence, the Security Forces and State Police will not launch operation against the two groups. A Joint Monitoring Group has been set up to oversee implementation of Suspension of Operations. Cadres of the two groups will be accommodated in the designated camps, identity cards issued to the cadres and arms and ammunition kept under double lock within the designated camps. Any violations will be taken up by the Joint Monitoring Group. Reasonable amount, as per Govt. norm, will be paid by the Govt., for maintenance of the cadres of the two groups who stay in the designated camps. Vocational training is also proposed to be provided to the cadres.
