3. Discussion and voting on demands for grants, 2007-2008 :-

#### **(1) DEMAND NO. 7 - POLICE :**

Shri O. Ibobi Singh, Chief Minister to move :

*“that a sum not exceeding Rs. 219,84,18,000 be granted to defray the charges which will come in course of payment during the financial year ending 31<sup>st</sup> March, 2008 in respect of Demand No. 7 - Police”*

#### **(A) MOTION FOR DISAPPROVAL OF POLICY CUT :**

Dr. I. Ibohalbi and

Shri R.K. Anand, MLAs to move :-

*“That the amount of the demand be reduced to Re.1”.*

On account of :-

- (i) Failure of police modernisation in an uniform way.
- (ii) Misuse of power by security personnel and failure to control them.

#### **(B) MOTION FOR TOKEN CUT :**

Shri O. Joy Singh, MLA to move :-

*“That the amount of the demand be reduced by Rs.100”.*

On account of :-

- (i) Failure to control excess and atrocities committed by security personnel.
- (ii) Failure to improve public-police relation.

(2) **DEMAND NO. 24 - VIGILANCE :**

Shri O. Ibobi Singh, Chief Minister to move :

*“that a sum not exceeding Rs. 85,15,000 be granted to defray the charges which will come in course of payment during the financial year ending 31st March, 2008 in respect of Demand No. 24 - Vigilance.”*
